October 17, 2012
Winnipeg, Ontario

1. **Welcome/Prayer** - Glen welcomed everyone and asked Dr. Warren Heckman (FCA US chairman) to open the meeting in prayer. The meeting began at 2:00 pm
2. **Roll Call of Delegates:** A paper was made available and everyone was asked to sign in as a delegate or an observer.
3. **Description of Voting Delegates** – Glen explained voting is done by those who have their names in the FCA Directory. Those who are new to the FCA or representing their church must be giving a copy of letter from their church. No letters were presented.
4. **Affirmation of Meeting Officers:** Chair: Glen Forsberg; Recording Secretary Brad Montsion – Parliamentarian – Robert Parmenter

Motion 2012:10:1 – Wayne Kent motioned; Paul Vallee approved meeting officers; Carried

5. **Affirmation of the Agenda** - Everyone was given an agenda in their convention packet

Motion 2012:10:2 - Cliff Stalwick motioned to approve the agenda with changes; Wilson Kadavil seconded, Carried

The agenda was amended to include the following items

1. To honour Violet Crane
2. To accept the handbook revision
3. To thank the organizing committee of the convention

6. **Minutes of October 19, 2011 had been distributed to every member/church and were placed on our website**

Motion 2012:10:3 - John Lucas III motioned to approve the October 19, 2011 Convention minutes as presented by Glen Forsberg; Dave Reimer seconded. Carried

7. **Convening of the Convention and Congratulations**

Motion 2012:10:4 - Dr. John Lucas motioned that the Fellowship of Christian Assemblies Annual Conference convening from October 16-18/12 in Winnipeg, MN does extend heartfelt congratulations to Mrs. Violet Crane on the occasion of her 96th birthday with grateful thanks to God for her many years of dedicated service to the FCA; Glenn Breitkreuz seconded; Carried

8. **Reports** – most reports were included in the convention manual – the following were given verbally

Report of the Elders. Glen Forsberg presented a report earlier today and it was in the convention handbook.

Report of the Secretary-Treasurer

Motion 2012 10:5 – Robert Parmenter motioned to accept the Secretary-Treasurer Report; George Bradley seconded ; Carried

Motion 2012:10:6 – Luke Inberg motioned to approve the Financial Statements for 2012; Wayne Kent seconded; Carried (addendum – 1)

Living Faith Bible College – They have an individual who is willing to edit all the video courses. He spoke on the Ugandan Project and the View Book. Paul thanked the churches that have supported them in the past through financial giving and hosting teams and also those who took in the interns.

Motion 2012:10:7 - Peter Visscher motioned to accept the Living Faith Bible College report; Terry Sellen seconded; Carried

FCA Plus – George Bradley spoke on the benefits of joining FCA Plus. It includes a long term/short term disability; dental/orthodontic and medical coverage as well as a death benefit. Rates differ whether it is coverage for individuals or families. He encouraged churches to get involved.

Motion 2012:10:8 - Jim Reimer motioned to accept the FCA Plus Report; Greg Newman seconded; Carried

Bursary Fund – Jim Reimer encouraged ministers to take advantage of this fund. We have never used up the fund that is set aside every year.

Motion 2012:10:9 - Duane Siemens motioned; David Reimer seconded to accept the Bursary Fund report; Carried

Scholarship Fund – Bill Green explained that the fund began at Temple Bible College; “This fund was initiated by the board of directors (Lorraine Myrholm, Ralph Kassen, Glen Forsberg, -----) of the former Temple Bible College. Einar Myrholm

served as a motivated member of the new Scholarship Fund for the past several years, - ____ of which he served as Chairman.”

They still need more delegate churches to help in the funding. He spoke of the scholarships of \$1500 and the Einar Myrholm award is \$3000. They cannot fund anymore worthy candidates. He gave out 5 \$1500.00 scholarship awards to Alicia Hien; Lance Tyrer; Amy Crocker; Amy Fry; Leah Payne.

The Einar Myrholm award for \$3,000.00 was awarded to Charis Reich.

Motion 2012:10:10 - Lorne Fisher motioned; Cliff Stalwick seconded to accept the Scholarship Fund report; Carried

New membership fee activated – We have activated the .5 % for all churches for the 2013 registration fee.

9. Current projects for 2013

Policy papers on Ethics – Glenn Breitzkreuz encouraged everyone to get involved with their boards to present a biblical, loving and sound policy for our future. We asked whether there is a cutoff date and will the final document be scrutinized by legal counsel. Cliff Stalwick spoke of a German pastor who was removed from ministry for taking a stand against same-sex marriages. We need to be proactive. It was asked whether there would be any statement about marriage/remarriage/common law. It has been considered.

20/20 vision – “This initiative was founded at the 2011 convention to support church planting and leadership training.

Convention time of year – We are considering changing our conventions to a permanent spring convention instead of a fall convention.

Motion 2012:10:11 - Dave Reimer motioned; Dennis Dunlop seconded to accept in principle moving the convention from fall to spring for our annual conventions beginning in 2015 as long as it is held on a different week than the US convention; Carried

10. Revised handbook

Motion 2012:10:12 - Jim Reimer motioned to approve the revised handbook that is now placed upon the FCA website; Lovelace St. John seconded; Carried

Note: The newest one has the addition of the minimum standards for licensing/ordination. It also included the changes to the leadership structure and the wording has been changed from sponsoring churches to endorsing churches.

11. Financial Statement/Budget presentation and vote

Motion 2012:10:13 –Paul Reich motioned to approve the budget until the Oct 2013 convention ;Greg Fraser seconded; Carried (addendum – 2)

12. Elder Elections

Jim Reimer, Paul Reich and Glenn Breitkreuz were for election in 2012

Eldership Structure - Voting of eldership candidates to serve for a 3 year term (to be until 2015) were Glenn Breitkreuz, Jim Reimer and Paul Reich. Voting was by ballot. We required a vote of 80 % of the 60 total ballots. Wayne Kent prayed for God's direction before the voting took place.

David Duinker and George Bradley checked the ballots. The three candidates were voted in by closed ballot all receiving the required 80%.

Motion 2012:10:14 – Dave Reimer motioned and Wilson Kadavil seconded to destroy the ballots; Carried

13. Convention dates & planning teams

The 2013 convention will be held in Nelson, BC with a Theme "*Rural Communities to Urban Centres.*" – *Thy Kingdom Come*" Jim handed out a flyer to promote the convention. It will offer practical tools to innovate and as well as times of revitalization and inspiration. Ontarians can take a flight to Spokane, WS for ½ the price and then a bus can be arranged. There are great rates on the hotel.

April 22-24/14 Convention for Canada and USA ministers

Paul Vallee made the invitation to the convention which will be similar to one they hosted for the 2010 convention. It will be held at the Sheriton Hotel. We had 550 people attending in 2010. The hotel rate will be \$149.00 but other area hotels will be cheaper. Paul spoke on E21 (God to Empower us by the Holy Spirit). Bill Wilson will be the keynote speaker. Theme -

“Empowered by the Spirit/Grounded to the Word.” Dr. Tremper Longman III will also be speaking on how the Bible is translated.

Motion 2012:10:15 - Wayne Kent motioned to accept the invitation to host the 2014 FCA International Convention from Paul Vallee and Living Stones Church in Red Deer; Glenn Breitkreuz seconded; Carried

14. Next Annual Meeting Date

Next Annual Business Meeting will be Oct 23, 2013
There were 173 delegates at this conference.
